

**ORDINANCE NO. 2019-0916 A**

**An Ordinance Amending Section 33.022 of the Warren County Zoning Ordinance Relating to Special Exception Permits for Confined Animal Feeding Operations**

WHEREAS, the Warren County Area Plan Commission, following a duly noticed meeting on August 20, 2019, has certified its recommendation of either a favorable, unfavorable or no recommendation, to amend Section 33.022 of the Warren County Zoning Ordinance; and

WHEREAS, the Board of Commissioners of Warren County desires to amend the Warren County Zoning Ordinance to require that all feeding yards, stockyards and CAFOs will require a Special Exception Permit;

NOW, THEREFORE BE IT ORDAINED by the Board of Commissioners of Warren County, that Section 33.022 of the Warren County Zoning Ordinance is amended to provide as follows:

Amend Section 33.022 of the Warren County Zoning Ordinance to require a Special Exception permit for all CAFOs as follows:

FROM: "Feeding yards for animals in farm-to-market transit or stockyards confinement feeding of livestock where the yard is less than one mile from a residential, commercial, or industrial district, or a residence other than the residence of the owner or lessor of the lot."

TO: "Confined feeding operations (CAFOs), feeding yards for animals in farm-to-market transit, or stockyard confinement feeding of livestock."


This Ordinance shall be in full force and effect from and after its adoption by the Warren County Board of Commissioners, and publication as required by law.
