## WARREN CIRCUIT COURT - RULES FOR PROBATION/SUPERVISION

 $\Box$  Amended Rules following Revocation\*

As a condition of Probation (or Juvenile Supervision), I am Ordered by the Court to comply with the following:

1. I must behave well and not engage in any unlawful conduct, complying rules of pretrial release, bail, probation, parole.

2. Attend school, obtain my G.E.D., or working regularly, unless exempted by my Probation Officer.

3. Unless prescribed by a physician, I must totally abstain from the use or possession of: alcohol, substances containing alcohol; controlled substances; drug paraphernalia (including, hemp or low THC extracts) and not be in a place where controlled substances are being used, manufactured, or grown unlawfully. When taking prescription medication, I will take it as prescribed.

4. I waive all Fourth Amendment rights and allow search and seizures without cause and without suspicion. I shall submit to all drug and alcohol tests requested, at my expense. I shall not refuse to submit to any such testing or submit or attempt to submit a dilute, or adulterated samples.

5. I must abide by reasonable rules and regulations established by the Probation Office, including executing medical or HIPAA releases to monitor compliance with these Rules.

6. I must (a) report as directed; (b) report in person to my Probation Officer every calendar month, unless excused by Probation in writing; (c) report any change of address, telephone number, employment, arrest or service of a criminal summons within twenty-four (24) hours of the event; (d) provide a DNA sample, state issued ID, or fingerprints, if requested; and (e) report in person to my probation officer within one (1) business day following release from jail or prison.

7. I must (a) remain in the State of Indiana or my home state, if I am not an Indiana resident, when placed on probation, unless permitted to leave by my Probation Officer in writing; and (b) waive extradition to the State of Indiana.

8. I must not possess any firearm or ammunition, unless I obtain written permission from my probation officer.

9. I must: (a) perform any community service ordered by the Court, as approved by the Probation Office; and (b) serve any jail or community corrections sentence, and comply with all rules thereof. Intermittent sentence to be served *pro rata*, over probation.

10. I must, as ordered by the Court at sentencing, **PAY THE FOLLOWING**, <u>during probation</u>: (a) any probation fees, restitution, Court Costs, pauper counsel fees, or other statutory fees, assessed by the Court at sentencing and (b) pay court ordered child support. If costs, fines or fees are converted to community service, due to indigency, those hours shall be completed as a term of probation under Rule 9 above. All fees shall be paid *pro rata* over the term of probation, unless approved otherwise by Probation.

11. I must, if an element of my offense involved the use, possession, or manufacturing of alcohol, paraphernalia, or a controlled substance, or if otherwise ordered by the Court,: (a) not be in a place where the primary business involves the sale or distribution of alcohol (i.e., tavern/liquor stores) and (b) participate in and satisfactorily complete a substance abuse assessment approved by the Probation Department and follow all recommendations made as result thereof such as in-patient treatment, education, counseling, or relapse prevention and pay any fees for said programs and services during the term of probation.

12. Comply with any probation term specified in a plea agreement or as advised at sentencing or disposition.

13. The Court further imposes the special probation terms, which I must comply with as approved by Probation:
