**A Resolution to Confirm the Organization of
Various Boards, Commissions and Districts in Warren County, Indiana**

WHEREAS, the Warren County Commissioners (“Commissioners”) and the Warren County Council (“Council”) are directed to make various member appointments to the Warren County Area Plan Commission (“Plan Commission”), Warren County Board of Zoning Appeals (“Board of Zoning Appeals”), Warren County Solid Waste District, Fountain and Warren Health Department, Alcohol and Tobacco Commission, Williamsport-Washington Township Library Board, West Lebanon Library Board, Kankakee-Iroquois Regional Planning Commission (KIRPC), Wabash River Corridor Commission, District 4 Planning Commission, Warren County Redevelopment Commission, Warren County/Cicott Park Board, 911 Board and Property Tax Assessment Board of Appeals (PTABOA).

WHEREAS, the Commissioners, the Council, Plan Commission, Board of Zoning Appeals, Warren County Solid Waste District, Fountain and Warren Health Department, Alcohol and Tobacco Commission, Williamsport-Washington Township Library Board, West Lebanon Library Board, Kankakee-Iroquois Regional Planning Commission (KIRPC), Wabash River Corridor Commission, District 4 Planning Commission, Warren County Redevelopment Commission, Warren County/Cicott Park Board, 911 Board and Property Tax Assessment Board of Appeals (PTABOA) desire to define the members of the Plan Commission, the Board of Zoning Appeals, Warren County Solid Waste District, Fountain and Warren Health Department, Alcohol and Tobacco Commission, Williamsport-Washington Township Library Board, West Lebanon Library Board, Kankakee-Iroquois Regional Planning Commission (KIRPC), Wabash River Corridor Commission, District 4 Planning Commission, Warren County Redevelopment

Commission, Warren County/Cicott Park Board, 911 Board and Property Tax Assessment Board of Appeals (PTABOA), and to agree on their terms of office, in order to clarify the existing members and terms on such boards and commissions;

NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

Warren County Area Plan Commission. Pursuant to I.C. 36-7-4-208, the Warren County Area Plan Commission shall contain the following six (6) members:

- (1) One (1) member appointed by the County Executive from its membership, which includes:
 - (a) Marty Blessing, whose term expires January 1, 2024.
- (2) One (1) member by the County Fiscal body from its membership, which includes:
 - (a) Perry Conrad, whose term expires January 1, 2024.
- (3) The county agricultural extension educator, if the county agricultural extension educator is a resident of the county. If the county agricultural extension educator is not a resident of the county, then the County Executive shall select a resident of the county who is property owner with agricultural interest, which includes:
 - (a) Becky Ehler, whose term expires January 1, 2025

Warren County Board of Zoning Appeals. Pursuant to I.C. 36-7-4-902, the Warren County Board of Zoning Appeals shall contain the following five (5) members:

- (1) Two (2) citizen members, of whom one (1) must be a member of the Area Plan Commission and one (1) must not be a member of any plan commission, appointed by the county legislative body, which includes:
 - (a) Marty Blessing, whose term expires January 1, 2025;
 - (b) Neal Austin, whose term expires January 1, 2024.

Warren County Solid Waste District. Pursuant to I.C. 13-21-3-5, the Solid Waste

District shall contain the following seven (7) members:

- (1) Three (3) members appointed by the County Executive from the membership of the County Executive, which includes:
 - (a) Adam Hanthorne, whose term expires January 1, 2023;
 - (b) Clay Andrews, whose term expires January 1, 2023; and
 - (c) Craig Greenwood, whose term expires January 1, 2023.
- (2) One (1) member appointed by the County Fiscal body from the membership of the Fiscal body, which includes:
 - (a) Ethan Foxworthy, whose term expires January 1, 2023.
- (3) Two (2) members appointed from the membership of the legislative body of the municipality with the largest population in the county appointed by the legislative body of that municipality, which includes:
 - (a) Paul Coffman, whose term expires January 1, 2023;
 - (b) Jim Lanham, whose term expires January 1, 2023.
- (4) One (1) member who is a member of the legislative body of a town that is not the municipality having the largest population in the county and who is appointed by the executive of that county to represent the municipalities in the county other than the municipality having the largest population, which includes:
 - (a) Greg Robison, whose term expires January 1, 2023.

Fountain and Warren Health Department. Pursuant to I.C. 16-20-3-2, a multiple county board of health shall contain at least seven (7) members, of which the following are appointed by Warren County:

- (1) Four (4) members appointed by the Warren County Commissioners, which includes:
 - (a) Jennie Larson, whose term expires January 1, 2023;
 - (b) Mark Straw, whose term expires January 1, 2023;
 - (c) Haley Brooks, whose term expires January 1, 2025; and
 - (d) Dr. Jon Inman, whose term expires January 1, 2025.

Alcohol and Tobacco Commission. Pursuant to I.C. 7.1-2-4-6, the local Alcohol and Tobacco Commission shall contain the following three (3) members:

- (1) One (1) member appointed by the Board of County Commissioners, which includes:
 - (a) Ralph Shrader, whose term expires January 1, 2023.
- (2) One (1) member appointed by the County Council, which includes:
 - (a) Matt Commons whose term expires January 1, 2023.
- (3) One (1) member appointed by the President of the Town Council of the town within the County having the largest population, which includes:
 - (a) Jim Beyer, whose term expires January 1, 2023.

Williamsport-Washington Township Library Board. The Williamsport-Washington Township Library Board shall contain one (1) member appointed by the County:

- (1) One (1) member appointed by the Board of County Commissioners, which includes:
 - (a) Teresa Ligara, whose term expires January 1, 2025.

West Lebanon Public Library Board. The West Lebanon Public Library Board shall contain (1) member appointed by the County:

- (1) One (1) member appointed by the County Council, which includes:
 - (a) Patsy Reynolds, whose term expires January 1, 2024.

Community Action Board of Directors. *Not sure why this is in here, not required to make appointment under I.C. 12-14-23-6.*

Kankakee-Iroquois Regional Planning Commission. The Kankakee-Iroquois Regional Planning Commission (KIRPC) shall contain the following three (3) County appointees:

- (1) Two (2) members appointed by the Board of County Commissioners, which includes:
 - (a) Paula Max, whose term expires January 1, 2023; and
 - (b) Craig Greenwood, whose term expires January 1, 2023.
- (2) One (1) member appointed by the County Council, which includes:
 - (a) Brian Jordan, whose term expires January 1, 2023.

Wabash River Corridor Commission. The Wabash River Corridor Commission shall contain the following two (2) County appointees:

- (1) One (1) member appointed by the Board of County Commissioners, which includes:
 - (a) Louise Jewell, whose term expires January 1, 2023.
- (2) One (1) alternate member appointed by the Board of County Commissioners, which includes:
 - (a) Steve Eberly, whose term expires January 1, 2023.

District 4 Planning Committee. The District 4 Planning Commission shall contain the following County appointee:

- (1) One (1) elected official, proxy or President of the Board of Commissioners, which includes:
 - (a) Bryan Lanham, whose term expires January 1, 2023.

Warren County Redevelopment Commission. Pursuant to I.C. 36-7-14-6.1, the Warren County Redevelopment Commission shall contain the following five (5) members:

- (1) Three (3) members appointed by the County Executive, which include:
 - (a) Gene Fowler, whose term expires January 1, 2023;
 - (b) Brandon White, whose term expires January 1, 2023; and
 - (c) Ethan Foxworthy, whose term expires January 1, 2023.
- (2) Two (2) members appointed by the County Fiscal Body, which include:
 - (a) Ben Dispennett, whose term expires January 1, 2023; and
 - (b) Derek Puterbaugh, whose term expires January 1, 2023.

Warren County/Cicott Park Board. Pursuant to I.C. 36-10-3-4, the Warren County

Park Board shall contain the following five (5) members:

- (1) Two (2) members appointed by the Judge of the Circuit Court, of whom no more than one (1) member can be affiliated with the same political party as the members appointed by the County Fiscal body, which include:
 - (a) Carrie Austin, whose political affiliation is Republican and whose term expires January 1, 2024; and
 - (b) Nathan Smiley, whose political affiliation is Democrat and whose term expires January 1, 2024.
- (2) One (1) member appointed by the County Executive, which includes:
 - (a) Miles Stucky, whose term expires January 1, 2024.
- (3) Two (2) members appointed by the County Fiscal body, of whom no more than one (1) member can be affiliated with the same political party as the members appointed by the Circuit Court Judge, which include:
 - (a) Brian Jordan, whose political affiliation is Republican and whose term expires January 1, 2024 Republican and
 - (b) John Henry, whose political affiliation is unknown and whose term expires January 1, 2024.

911 Board. The 911 Board shall contain the following two (2) members:

- (1) One (1) member appointed from the Board of Commissioners, which includes:
 - (a) Adam Hanthorne, whose term expires January 1, 2023.
- (2) One (1) member who is a member of the public, which includes:
 - (a) Phil Astell, whose term expires January 1, 2023.

Property Tax Assessment Board of Appeals. Pursuant to I.C. 6-1.1-28-1, the Property Tax Assessment Board of Appeals (PTABOA) shall contain the following three (3) members, of whom no more than two (2) of the three (3) members may be of the same political party:


- (1) One (1) member appointed by the County Fiscal body, which includes:
 - (a) Lori Heidenreich, whose political affiliation is Republican and whose term expires January 1, 2023.

- (2) Two (2) members appointed by the County Commissioners, which include:
 - (a) David Smyth, whose political affiliation is Republican and whose term expires January 1, 2023.


 - (b) Lon Akers, whose political affiliation is unknown and whose term expires January 1, 2023.
