## Warren County Commissioners Approve Emergency Air Medical Membership Agreement

*Agreement will provide air medical transport benefits for all Warren County, IN residents*

WARREN COUNTY, IN, 10 NOVEMBER 2022 – The Warren County Commissioners approved a renewal of the emergency air medical transportation agreement with PHI Cares. The agreement will continue to provide air medical transport benefits for all residents of Warren County when they are transported by a PHI Air Medical aircraft in the region. The new agreement begins on January 1, 2023.

The PHI Cares membership program supports all the households and residents of Warren County, Indiana. With the renewal of this agreement, Warren County residents will not be required to pay any additional out-of-pocket expenses for their emergency air medical transportation when a PHI Air Medical aircraft in the region transports them from Warren County or a surrounding county, including Benton, Tippecanoe, Fountain, Vermillion, and Vermillion, IL.

Residents should **always call 911 first** when they have a medical emergency. The 911 dispatchers will dispatch an ambulance. The attending paramedics will determine if an air ambulance is needed. If a resident is transported by a PHI Health aircraft, they should notify the PHI Cares membership department at 1.888.I.Fly.PHI (1.888.435.9744) and provide them with the Warren County PHI Cares membership number #26741 and their date of transport.

PHI Cares will be providing the Warren County Commissioners with special membership ID cards that include the PHI Cares membership number. Residents can obtain their PHI Cares membership cards from the following locations after January 15<sup>th</sup>, 2023:
